#### Minimum Balance Requirements:

- No minimum balance required.
- You must deposit at least \$100.00 to open this account.

#### Fee/Service Charge:

- A monthly fee of \$10.00 will be imposed every monthly statement cycle.
- An additional monthly fee of \$3 per statement will be assessed if you do not receive e-statements.

#### Interest Rate:

- The interest rate for your account is .1000% with an annual percentage yield of .10%. Your interest rate and annual percentage yield may change at our discretion. The interest rate for your account is based on the First National Bank of Middle Tennessee Index. We may change the interest on your account daily.
- You must maintain a minimum balance of \$.01 in the account each day to obtain the disclosed annual percentage yield.

#### Compounding and Crediting:

- Interest will be compounded monthly. Interest will be credited to account on the last day of the statement cycle. If you close your account before interest is credited, you will receive the accrued interest.

#### Balance Computation Method

- We use the daily balance method to calculate the interest on your account. This method applies a daily periodic rate to the principal in the account each day.
- Interest begins to accrue no later than the business day we receive credit for the deposit of noncash items (for example, checks).
